

PRIVACY NOTICE PURSUANT TO ARTICLE 13 OF EU REGULATION NO. 679/2016

Zefiro S.r.l., with registered office in Pistoia (PT), Via di Montebuono 23, 51100, Fiscal Code and VAT 01449860475 (hereinafter, **Zefiro** or the **Company**), in its quality of data controller, intends to provide information on the methods of processing of your personal data during the consulting and browsing the website www.replast.it (hereinafter, the **Website**) in accordance with Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and related implementing legislation (hereinafter, jointly, referred to as the **Regulation**).

1. SOURCE OF PERSONAL DATA PROCESSING

The personal data collected and processed by the Company are provided directly by you when interacting with the Website. In particular, the personal data collected and processed by the Company are those:

- a) collected while browsing the Website (including IP addresses, type of browser used, operating system, information on the pages you visit within the Website, access time, permanence on the single page, internal path analysis and other parameters related to the operating system and the user's computer environment);
- b) provided directly by you following the sending of a request for information by filling the form "*Contact us*" on the Website;
- c) provided directly by you following the sending of a request for quotation by filling the form in the "*Ask for a quotation*" area on the Website;
- d) provided directly by you when registering on your personal area ("*Access to stock area*") of the Website in order to obtain information on the services offered by the Company, including verification of the storage of goods.

2. PURPOSES OF PERSONAL DATA PROCESSING

The personal data - referred to in point 1 above, letters a) and b) - are processed by Zefiro for the following purposes:

- a) browse the Website;
- b) handling of request for information;
- c) handling of requests for quotes;
- d) handling of registration on the personal area on the Website and use of the related services;
- e) sending updates (newsletters) in relation to Zefiro products of the same nature as those already purchased or requested by you, unless otherwise indicated by you;
- f) sending satisfaction questionnaires regarding services and/or products purchased/requested;
- g) statistical purposes on anonymized data.

3. LEGAL BASIS

The legal basis for data processing for the purposes referred to under point 2, letters a), b), c) and d), is the provision of a service and execution of a contract. The legitimate interest of Zefiro in offering products of the same nature as those already purchased and / or requested by you pursuant to Article 6.1 lett. (f) of the Regulation, unless you object at the time of receipt of the communication or subsequently (for the purpose referred to in letter e)). Your consent is not necessary for the processing of anonymized data for the purpose referred to under letter e).

4. MEANS OF PROCESSING

For the purposes under paragraph 2 abovementioned, the processing of personal data shall be made by the Company by computer, telematic, paper and manual instruments, in compliance with the confidentiality and safety rules provided by the law.

5. PROVISION OF PERSONAL DATA AND CONSEQUENCES OF ANY REFUSAL

The provision of the personal data is optional. However, any refusal to provide the data for the purpose referred to under letter a) of paragraph 2, shall lead to the impossibility to provide certain services and the experience of browsing the Website would be compromised. Any refusal to provide the data for the purpose referred to under letters b), c) and d) of paragraph 2 shall lead to the impossibility to proceed with the handling of the request for information and use of the services on the Website. Any opposition to the processing for the purpose referred to in point 2 letter e) and f) will not entail any consequences, except for the impossibility of receiving newsletters and interest detection questionnaires relating to Zefiro's services and/or products of the same nature as those you may have already purchased and/or requested.

6. RECIPIENTS OF PERSONAL DATA

Your personal data shall not be disseminated. Within the organization of the Company, the personal data may be processed by the relevant offices entrusted with the execution of certain processing. In order to provide its services, Zefiro, may communicate your personal data to third parties, for the purpose of managing the use of the Website. Such subjects will have access to the personal data necessary to perform these functions (and may not use them for different purposes), and will be required to process the data in accordance with applicable law. The aforementioned suppliers will act as data processors appointed by Zefiro and will be included in an updated list, which can be easily and free of charge known by sending a request to the address indicated in paragraph 9 of this Privacy Notice.

7. DATA RETENTION PERIOD AND DATA STORAGE LOCATION

Any data collected for the purposes indicated under paragraph 2 lett. a), b), c) and d) abovementioned shall be retained for the period of time necessary to manage the correct use of the Website, your registration on the Website and your request for information. Subsequently, the personal data will be retained for the period of time not exceeding: (i) the data retention period provided for by current legislation

for each category of data; and (ii) the limitation period provided for by law to enforce or defend a claim against you or third parties. The data collected for the purposes of processing indicated in points e) and f) of point 2 will be kept until you object to the receipt of informative material and questionnaires regarding Zefiro's services and/or products of the same nature as those you may have already purchased and/or requested,, except in the case in which the data are also processed for other legitimate purposes, including the case in which it is necessary to keep the data to provide a service to you, to defend the rights of Zefiro in relation to disputes outstanding at the time of the request or on the indication of the public authorities.

Your personal data shall be stored on servers located within the European Union. Zefiro will not transfer your personal data outside the European Union.

8. DATA SUBJECT RIGHTS

Pursuant to the Regulation, you are entitled to exercise the following rights:

- a) access your personal data;
- b) obtain a copy of the personal data supplied by you (e.g. portability);
- c) request the rectification of your data stored by Zefiro;
- d) limit the processing of your data or oppose to any further processing;
- e) request the deletion of personal data, where Zefiro has no longer a legitimate legal basis for further processing;
- f) oppose to any data processing carried out on the basis of a legitimate interest pursued by Zefiro;
- g) the right to lodge a complaint before the competent Authority for the Protection of Personal Data.

9. DATA CONTROLLER

10. AMENDMENTS

Notwithstanding that Zefiro in any case shall not proceed to processing operations other than those expressly authorized and/or requested by each user, this Privacy Notice may be amended from time to time in order to comply with new provisions of law, the modification of Zefiro's data processing policies and/or following changes to the features of the Website and/or Zefiro's services. Each updated version of this Privacy Notice shall be made available on the Website in the dedicated section: Zefiro therefore invites all users to periodically consult the aforementioned section in order to be always informed on the latest published version.
